I hope you all are well and if you would join me in a moment of silence again for our dear brothers and sisters suffering from this disease, both inside and outside the rooms of A.A. (Silence) Today I learned that one of my early sponsors committed suicide. She had 45 years sobriety, but as our beloved Bill told us, our defense must come from our higher power and without this power, we will succumb to this fatal disease no matter how many years we are sober. Lisa saved my life and countless other women in the Denver area as a dedicated servant to her group and AA. I am saddened to know she was suffering and sought solace in drinking again. Many people tried to talk to her and told her how important she was to them, but king alcohol spoke louder and now she is dead.

I also wanted to add to Jane's legacy to the District. When I was first talking to people in Hayward, regarding how we could revive our District, Jane was the person I spoke to and asked questions about past service activities that our District could be involved with to provide outreach 12th step work to our AA community. She also was the first person I literally talked to from Hayward before we moved there as I called the Alano Club to find out about meetings. We didn't always agree on the process, but she was able to guide me to the people in the jail and those who had done service work there. She made sure that her Saturday morning group -11:00am- supported the Area and the District with the outcome that this group was the first group to contribute 7th Tradition funds to Area, District and GSO. She had every intent to sign up to go to the jail when COVID-19 shut everything down and I am sure, had she lived, she would be front and center of this District now. I truly miss her and am so happy you all had this memorial for her and Al. I hope that those who attended the Meet and Greet there in Hayward on July 31st with our Area delegate Char and our Area Chairman, Bryon we're able to ask some questions of Char and the Conference outcome.

The Area Assembly in September will be an election one so will provide information as it becomes available. Also please make sure you have input to offer a title for the international conference to be held in a few years if you so desire. The list and information is in the first attachment that Roger sent you from Char.

Remember, we need to talk with people in our groups about upcoming Spring Conference in 2022 that we are helping to host hospitality room in Ashland. We can seek their involvement in this event.
