Delegate's Corner

Seasonal Greetings

I hope everyone is managing to stay warm during this chilly weather. For those who enjoy ice fishing as I do, this season offers its own rewards. Currently, my primary focus is preparing to share the agenda items and supporting materials for the 2026 General Service Conference, scheduled to take place in New York from April 26th to May 2nd of this year.

Preparation and Distribution of Agenda Materials

My efforts have been directed toward reorganizing the process so that all members of Area 74 can participate in discussions regarding agenda items and their background materials. To facilitate this, we have established three key opportunities for groups, Districts and Individual's to provide their group conscience, through GSRs, DCMs, and individual members. The process will begin with the release of agenda items and their background materials, anticipated during the second week of February. If the process mirrors last year, these materials will be distributed over several consecutive days. Upon receipt, I will promptly forward them to the Area DCMs, along with an updated contact list for Area 74 officers, committees, and past delegates.

Method Inspired by Area 20 (Northern Illinois)

As many of you know, I will be utilizing a method developed and used by Area 20 (Northern Illinois) for several years now. This method provides another distinct opportunity for the group conscience of Area 74 to be heard.

Opportunities for Participation

1. **Zoom Week:** Each conference committee will be represented, and agenda items will be presented by the respective Area 74 Chair. For example, Mike K, the Literature Committee Chair, will be present at the scheduled Zoom meeting. Additionally, the committee members will share the feedback collected so far at the Delegates' workshop on March 28th in Three Lakes, Wisconsin.
2. **Delegates Workshop:** The second opportunity to provide input will be at the Delegates Workshop in Three Lakes on March 28th. This event will be held at the Reiter Center in Three Lakes, Wisconsin. This will be a hybrid meeting. At this time, GSRs can share their group conscience, pose questions, and offer input on each agenda item directly to the committee chair if they have not already done so.
3. **Area Assembly:** The third and final opportunity before the delegate travels to New York for the General Service Conference will be at the Area Assembly in Rhinelander on April 18th. This meeting will allow GSRs a final chance to express their group conscience regarding specific agenda items.

Outreach and Participation

I am very enthusiastic about implementing this approach to communicate agenda items and background materials to everyone in Area 74. In addition, I plan to attend as many district meetings as possible, whether in person or via Zoom. I have already begun scheduling these visits for February and, if necessary, will continue into March prior to the Zoom Week discussions, which are scheduled from March 15th to March 22nd. Please refer to the attached "Zoom Week" schedule for dates, times, committee discussion topics, Zoom IDs, and passwords. There may be some changes to the names of facilitators for specific meetings, so if your name is listed, do not be concerned; I will reach out to each individual beforehand to ensure everything runs smoothly. Everyone is welcome to participate in these discussions.

We are trying something new this year in preparation for our Delegates Workshop. We will be hosting online discussion meetings from March 15th to the 22nd on the final agenda items. The schedule should be found in our area newsletter.

In my debriefing conversations after the Area Committee meeting, from several participants, a word was used that gave me inspiration. "Clarity". For me, this word reminds me of my purpose as your Panel 76 Area 74 Area Chair. These two motions will be presented with a second from the Area Committee to the Assembly. When a motion is sent to the Area Committee by the Assembly, the Area Committee is free to provide whatever solution they deem fit.

I'm hoping that our online discussion opportunities will help bring in new members from our area to see what this service experience is all about. I would ask that all of us in Area 74 service reach out to others in our fellowship to at least check this out. Oh, and don't fear about doing it right, just do it and trust the process to bring us through.

Motion: ECR CDPP Stipend for Past Delegates

Motion from D13 was read and the floor opened for discussion. Members discussed the purpose of supporting attendance at the ECR Conference of Past Delegates (ECR CDPP), including its value for service, leadership development, and representation at the General Service level. Questions were raised about whether the proposal should go to the Assembly, how it should be worded, and whether the funding should be a stipend or reimbursement. Several amendments were suggested regarding dollar limits, division of funds, and clarity of language.

Result: Motion to Reconsider passed.

Further discussion focused on clarifying whether the funds should be stipends or reimbursements and whether to return to the original motion with only the dollar amount adjusted.

Vote on Revised Amendment

Proposed wording:

Vote:

- Yes: 9 in person, 3 online (12 total)
- No: 7 in person, 5 online (12 total)

Result: Amendment failed. Motion returned to the original version.

Call the Question on Original Motion

Vote on call the question:

- Yes: 14 in person, 5 online (19 total)
- No: 0

Result: Call to question passed.

Final Vote on Original Motion

- Yes: 14 in person, 7 online (21 total)
- No: 2 online, 0 in person (2 total)

Result: Motion carried.

Final Outcome:

The original motion passed and will be forwarded to the Assembly fo

Final comment from the mic that the process while frustrating at times was a great example of how we come to decision as a body politic. We were asked to figure it out, and we did.

District 13 Update on conference 2027

Ad-Hoc Committee on Calendar Change:

- Brent H states that we are in the 2nd year. Asks that Ad-Hoc committee to resurrect itself and share information they may have on what has been working.

Motion: Removal of Past Delegate Voice and Vote

Discussion focused on whether Past Delegates should retain voice and/or vote at Area meetings. Members expressed concerns about equity, rotation of leadership, and whether Past Delegates having both voice and vote gives disproportionate influence compared to GSRs and DCMs. Some felt Past Delegate participation discourages newer members from speaking, while others emphasized the value of Past Delegate experience and minority opinion.

Several viewpoints were presented:

- Support for keeping both voice and vote.
- Support for keeping voice but removing vote.
- Support for keeping vote but removing voice.
- Support for removing both voice and vote.

Concerns were also raised about decorum, intimidation at the microphone, and whether Past Delegates should share experience through elected representatives rather than directly. It was noted that the issue affects Area structure and should ultimately be decided by the Assembly.

Two alternative motions were drafted:

1. One removing **voice** but retaining **vote** for Past Delegates.
2. One removing **vote** but retaining **voice** for Past Delegates.

Procedural discussion determined that the original motion and the two alternatives could be forwarded to the Assembly for consideration.

Seconded by: Jeff

Action:

To forward the original motion along with two alternative motions (one addressing removal of voice and one addressing removal of vote) to the Assembly for decision.

Outcome:

The issue will be presented to the Assembly with three options:

- The original motion,

- A motion removing vote for Past Delegates.

Final determination will be made by the Assembly.

A Note on Service and Seeking a New Area Webmaster

In the spirit of rotation and healthy service, I'd like to share that I am beginning the process of seeking a replacement for my role as Area Webmaster. I fully understand—and want to emphasize—that this is not something that happens overnight. It will likely take time to find the right person and get them trained and comfortable in the role, and I am more than willing to help with that transition so the Area continues to be well supported.

I began serving as Area Webmaster in the fall of 2018. At that time, our very first task was a big one: redesigning the entire Area website from the ground up using WordPress. Along with that came migrating our hosting away from GoDaddy, resulting in meaningful cost savings for the Area. It was a challenging and rewarding way to begin service.

Midway through my tenure, our focus shifted heavily toward supporting the Meeting Guide app. We worked closely with districts to help post and maintain their meetings in the app—often doing the legwork for them. This effort could not have come at a more important time, as we collectively adapted to the COVID lockdowns. During that period, I gathered and shared many documents and resources to help groups navigate unfamiliar territory, especially around setting up Zoom and hybrid meetings. Watching the Fellowship adapt so quickly and creatively was truly inspiring.

In more recent years, much of our energy has gone into the Area Online Chat. We were able to get the chat up and running quickly and train volunteers to serve. Today, every month, a dozen or more questions are answered through that service. It is an amazing thing to witness—quiet, consistent, and often unseen—yet clearly making a difference.

Throughout all of this, the website has continued to serve as a hub for the Area: emails, meeting lists, conference online registration, events, minutes, agendas, newsletters, and many other resources have been posted and updated—sometimes quickly, sometimes more slowly—but always with the goal of being helpful and accessible.

I want to thank the Area for allowing me to serve in this way. It is something I will always look back on with deep gratitude and joy. In a role like this, we will never fully know all the ways we may have helped a suffering alcoholic—but I truly believe many seeds have been planted, and many lives have been helped.

If you or someone you know may be interested in learning more about the Area Webmaster position, I would be glad to talk and share what the role looks like. Thank you again for the opportunity to serve.

I recently had the opportunity to attend the Deaf AA Forum through GSO. The focus of the forum was on recovery, Tradition 5, how can we carry the message of AA to the deaf alcoholic.

The deaf alcoholic has different needs than the speaking alcoholic. There is a cognitive impact for the deaf alcoholic as the primary language for most deaf alcoholics is some form of sign language. This effects how the deaf alcoholic thinks, learns and accesses information as well as literature. It is important to include the deaf alcoholic in the process of their recovery.

There are online meetings for the deaf alcoholic. There may or may not have an interpreter. It is suggested that interpreters are certified professionals. It is suggested that the certified interpreter is fluent in ASL and language and culture.

For me this forum is about tolerance of the person who is different. Accessibility is about AA being there for the alcoholic who still suffers.



(NEW YORK, NY) – January 22, 2026 – The General Service Board of Alcoholics Anonymous (A.A.) has announced three new Class A (nonalcoholic) trustees have joined the board: Tom Ivester, M.D., of Chapel Hill, North Carolina; Kelly Parsley of Helena, Montana; and Veronica Ramirez of Weslaco, Texas. The trustees will serve six-year terms.

Class A trustees are friends of Alcoholics Anonymous selected for their professional expertise and the unique perspectives they bring to the General Service Board's work of supporting A.A. and carrying its message of recovery. Class A trustees also serve in certain public-facing roles; as nonalcoholics, they need not maintain anonymity in the media as do A.A. members.

Tom Ivester is chief clinical officer for Novant Health's triad region of North Carolina and a specialist in maternal-fetal medicine. Having grown up around Alcoholics Anonymous through his father's long-term sobriety, Ivester brings more than 30 years of medical and leadership experience. He serves on the Archives, Public Information, Cooperation with the Professional Community and Treatment and Accessibilities committees, where he hopes to help increase understanding of A.A. within the medical community.

Kelly Parsley is a professor of health sciences whose academic career has focused on alcohol use and abuse. Her connection to A.A. deepened after attending [open meetings](#), where she witnessed the Fellowship's impact firsthand. She serves on the Corrections Committee, as well as subcommittees on the [Plain Language Big Book](#), the forthcoming Fifth Edition of the Big Book, and the International Committee.

Veronica Ramirez is a retired chief probation officer for the Eastern District of Louisiana with more than two decades of experience in federal probation and community corrections. Throughout her career, she regularly referred individuals to A.A. and observed its effectiveness in supporting long-term change. She serves on the Corrections Committee, the Cooperation with the Professional Community/Treatment and Accessibilities Committee, and the International Convention/Regional Forums Committee.

- Tracking new groups in their subdistricts
- Monitoring changes in GSRs
- Keeping group status updates (active/inactive)

How Does GSO Support DCMs?

The General Service Office understands that the DCM's role is essential in assisting with data stewardship, so DCMs have read-only access to Fellowship Connection as an aid to "facilitate the widely desired goals of exact information, stronger communication, & responsible use of A.A.'s resources."



Collaboration is Key!

While DCMs have read-only access in Fellowship Connection, district registrars do not. That's why DCM/Registrar teamwork is essential! Let your district registrar know if a group has dissolved, but you see an "active" status for the group in Fellowship Connection so we can get it corrected or any other incorrect information you may see.
